Warm greeting from the International Kabaddi Federation. We would like to take this opportunity to inform that Mr. Sathasivam is no longer associated with the International Kabaddi Federation.

This was subsequent action to the resolution on the matter of Mr. Satha Sivam in the virtual General body meeting dated 27.07.2026 of the International Kabaddi Federation. An inquiry finding with the highest authority of Malaysian governance in sports in relation to his insolvency and the rules pertaining to it as per Malaysian rules of the land applicable to holding any official position was conducted.

It is to inform that we are in receipt of the official findings in the matter of Mr. Satha Sivam and it is confirmed that Mr Satha Sivam stands ineligible, prohibited and disqualified for any association with the International Kabaddi Federation.

Further it is to inform that subsequent to resolution of the General body meeting, dated 27.07.2026 the International Kabaddi Federation Executive body and General Assembly has disassociated its working with the company in India

(cin .U92412MH2006NPL166287 / gst no. 08AADC18975N1ZO located at No. 203, Queens corner ,Queens Road ,Jaipur 302021) as per the resolution passed by the General body with regards to the expulsion of Mr. G Kasani,a letter of expulsion was intimated to Mr. G Kasani towards his acts contrary to the alignment of the rules and governance structure of the International Kabaddi Federation.

We advise you that any information they may have shared with you, in the last few days, or tries to share in the immediate future. Should be ignored and not acted upon as this is not International Kabaddi Federation approved information.
